All car must pass NZHRA scrutineering pre race inspection.

Helmets must be approved by Motor Sport New Zealand. Helmets with NZS 1884 are no longer acceptable.

All drivers & passengers must wear neck braces.

All drivers & passengers must wear the correct wristband. This will be inspected prior to every race. If no wristband is shown, the passenger will be removed from the vehicle.

Alcohol breath testing will be administered at the drivers briefing. Anyone failing this will be disqualified from racing.

No burnouts permitted within the Pit area. No Jandals or open shoes allowed.
